<b>Tuition – AUTO PAY REQUIRED</b>			
1. Families choosing the annual tuition option receive a \$50 discount (payment due by August 5). 2. Bi-annual payments are due August 5 and January 5. 3. Monthly payments are due August through May on the 5th or 20th of each month.

<b>Tuition Scholarships</b>
CCS scholarships may be available after families have applied and have been denied by the ESTF program. Scholarships cannot be combined, including state-funded scholarships or Calvary scholarships.

<b>Financial Policies</b>	
1. Calvary Christian School does not request nor accept government funding; therefore, it is necessary that fees and tuition be paid on a timely basis. No monthly statements will be mailed.	
2. Unpaid balances of tuition and Patriots Club cannot be carried over from month to month. Parents who do not keep accounts current within the FACTS billing cycle will be notified that their children may not attend classes or Patriots Club.	
3. To prevent delinquent accounts, parents are encouraged to select autopay in their FACTS account.	
4. Lunch accounts that reach \$100 past due will not be able to charge the account.	
5. All fees other than tuition are non-refundable and non-transferable.	
6. Tuition is non-refundable if the student has been to school any day during the month, or if the student drops out without proper notification. Exceptions will be made if account has been paid in full for the year.	
7. There is a \$35 fee for returned checks. FACTS assesses a \$30 fee for insufficient funds or late payments.	
8. Registration for Patriots Club is arranged through the front office. Fees may be paid in full or in nine monthly payments (September through May). It is the parent's responsibility to notify the front office if after-school care is discontinued.	
9. Monthly payments have been calculated based upon an annual rate and are due in full regardless of the number of school days in any given month.	
10. Parents of all children not picked up by 6 p.m. will be charged a \$20 fee plus \$3 per minute late per student.	
11. There will be a \$20 unscheduled drop-in fee per hour charged to the account of a student who is not picked up by noon (K3 and K4), 3:10 p.m. (grades K5-5), or 3:30 p.m. (grades 6-12).	
12. There will be a financial hold on report cards, transcripts, and other school records if payment is not current at the end of each grading period. This financial hold will remain in effect until the account is current. Students whose accounts are not up to date by the end of each semester will not be allowed to take their final exams for that semester. Students who do not take final exams receive no credit for that semester's work.	
13. Students may not attend CCS Summer Day Camp until the previous year's account is current.	
14. The designated financially responsible party in FACTS at the time of enrollment is responsible for all payments.	
15. Any special financial or payment arrangements must be requested in writing and approved by administration.	
16. CCS scholarships cannot be combined, including state-funded scholarships.
