

Calvary Christian School: Infectious Disease Crisis Management Plan

In an effort to keep parents, students, and teachers informed, CCS would like to communicate what steps are being taken to deal with the spread of Covid-19 in such a way that will allow us to keep the doors of the school open without endangering students and families. Below you will find how we are gathering information, processing this information, and the plan we are endeavoring to follow to provide as much of an uninterrupted schedule while taking all available precautions.

- 1. Gathering of information: In the light of media hype, community panic, partisan efforts, and even indifference, it is difficult to sort through everything that is out there. CCS will be careful to not overreact, or minimize the threat. We will be looking to local and national sources for information.
- 2. Some decision will require a judgement call from school administration. Other decisions will not be ours to make but ours to deal with as best we can.
- 3. In all things we are both trusting the Lord, and moving toward making preparations for how to handle what is put before us.

Hygene Emphasized

Handwashing Protocol.

Supervised handwashing with soap and water.

- All students at all bathroom breaks

- After all p.e. and recess activities

- Before and after eating

Use of hand santizer.

- All students every time they enter the classroom.

- Hand santizer should not be used in the bathrooms. Soap and water is most effective when water is present.

Classroom Sanitizing.

- Teachers should keep a log of date and times that desks/doorknobs and other common surfaces are wiped down with disinfectant wipes. A minumum of twice daily with one being between school days.

Online learning requirements.

Each student will need access to a computer that has internet access. Teachers will be using a combination of RenWeb and Moodle to implement online learning. Some materials will need to be uploaded/printed/scanned for grading purposes.
